## **Bailey's Bed and Bath Boarding Requirements**

To make your pet's stay with us safe, enjoyable, and efficient we have compiled a list of requirements for pets staying in our boarding facility.

- 1. SPAYED/NEUTERED: All dogs must be spayed/neutered by the age of six months to stay at Bailey's.
- 2. <u>VACCINATIONS</u>: To prevent the spread of disease while your pet is in our care, dogs must be current on rabies (both one year and three year vaccinations are acceptable), bordetella and distemper.
- 3. <u>FOOD</u>: We request that you provide your dogs regular food for their stay at Bailey's. Switching food suddenly can cause health issues such as upset stomach/diarrhea. If the dogs regular food is not provided or if their supply of food runs out during their stay Bailey's will provide food at an additional cost and cannot be held responsible for any health issues that may occur.
- 4. <u>PERSONAL BELONGINGS</u>: You are welcome to bring your pet's favorite bedding or toy for their stay, however, Bailey's cannot be held responsible for damaged bedding material or any other personal belongings left during the stay.
- 5. <u>PICK UP / DROP OFF HOURS</u>: During your dogs stay he/she will be out playing indoors and outdoors with other dogs quite frequently. While your dog is being dropped off and picked up all other dogs will be put back in their rooms to ensure the safety of everyone. For this reason, all pick up /drop off times must be scheduled in advance. <u>Pick up/Drop off times are by appointment only</u> between 7:30am and 7:30 p.m. Monday through Sunday. There are no drop offs/pick ups on major holidays. Dogs will not be released to their owners except at the appointed time.

## Bailey's Bed and Bath Boarding and Grooming Release

This Release is a part of the Bailey's Bed and Bath Boarding and Grooming Contract between Bailey's Bed and Bath (herein after called "Bailey's") and the pet owner whose signature appears on said contract (herein after called "Owner").

Owner agrees to pay the rate for boarding in effect on the date pet is checked into the Bailey's. Owner further agrees that the pet shall not leave the Bailey's until all charges are paid to Bailey's by Owner. Owner certifies to the accuracy of all information given about said pet. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.

- 1.) Owner represents to Bailey's that the pet has not been exposed to rabies or distemper within a 30 day period prior to boarding and is current on all vaccinations.
- 2.) External Parasites: We are a "Flea and Tick Free" facility. Any animal admitted that has live fleas and/or ticks will be treated with a flea bath and a topical dose of Flea and Tick prevention at the dog owner's expense.
- 3.) <u>Veterinarian Release</u>: All of my animals are current on Rabies, Distemper and Bordetella. For the safety of all animals, Bailey's cannot care for animals that are not up to date on these vaccinations. If any of my animals becomes ill, Bailey's is authorized to transport them to the veterinarian of record and/or the closest emergency veterinarian hospital. The veterinarian is to call us for authorization to treat. If we are unavailable and our pet's condition is deemed an emergency, the veterinarian is hereby authorized to treat the animal at his/her discretion. Owner agrees to pay the veterinarian fees for all emergency treatments and will not hold Bailey's responsible for any charges incurred.
- 4.) Cancellation Policy: I understand that if I fail to cancel my boarding reservation without 72 hours notice I will be charged for a full day of boarding. I also understand that if I fail to cancel my boarding reservation over a holiday without 72 hours I will be charged for two full days of boarding.
- 5.) <u>Abandoned dogs</u>: I agree that I will not neglect to pick up my dog by the time scheduled without providing notification. I understand that if I abandon my dog Bailey's, by default, will become the legal owner and will relinquish the dog to a guardian/shelter of Bailey's choosing.
- 6.) <u>Aggressive dogs</u>: Due to the open/free play policy of Bailey's aggressive dogs are not accepted. I understand if my dog acts aggressively he/she will be separated from other dogs during the remainder of the stay and will not be asked to return to Bailey's.
- 7.) Waiver of Liability/Assumption of Risk: As a pet owner leaving my pet at Bailey's I understand that there are certain risks of injury or illness that are out of the control of the staff of the Bailey's. Pets, by their very nature, are often times nervous, hyper excitable, and don't always use good judgment. Hence they sometimes injure themselves or others while playing with other pets or over-reacting to being enclosed. By signing the above contract the pet owner recognizes that there are inherent and potential risks involved with interactions between human and dogs as well as between dogs and other dogs which may result in property damage or bodily injury. Including but not limited to, permanent disability, injuries, sickness or death. There may be other risks not know to me nor readily foreseeable at this time. The pet owner fully accepts and assumes all risks and responsibility for all risks, including without limitation all losses, costs and damages incurred as a result of my dogs stay at Bailey's. Including any veterinarian expenses incurred on behalf of my dog. Sickness shall be defined to include any illness including but not limited to bordetella (Kennel cough) or any other form of contagious illness. Bailey's shall exercise reasonable care for the pet delivered by the Owner to Bailey's for boarding. I hereby release from liability Bailey's and all their agents, owners and employees from and against any and all injury, liability, claims, litigation, costs, losses, damages, expenses or demands resulting from my pets stay at Bailey's Bed and Bath.
- 8.) Grooming Liability Release: I understand that Bailey's will take every precaution to take excellent care of my pet. Bailey's will not be held responsible for clipper burns, minor nicks, or skin irritation resulting from grooming. We also cannot be held liable for any after-grooming effects for de-matting clipping procedures or problems uncovered on a badly matted or otherwise neglected coat. Bailey's will not be held responsible for any conditions or problems discovered during grooming and is authorized to seek veterinary care if they deem necessary.
